
The Bombay Stamp Act, 1958

No.-GHM-2010-56-M-STP-122009-2426-H1. In exercise of the power conferred by clause (a) of section 9 of the Bombay Stamp Act, 1958 (BOM LX of 1958), (hereinafter referred to as "the said Act"), the Government of Gujarat hereby amends Government Orders Revenue Department No. GHM/2005/26/M/STP/102004/UOR-13/H-1 dated 9th May, 2005 as follows namely:-

In the said order,

- (i) for the words "executed by the Developer of the Industrial park for purchase of land" the words "or lease executed by the Developer of the Industrial park for purchase of land or acquired land on lease by way of auction from Gujarat Industrial Development Corporation" be substituted
- (ii) before the words "executed by the units" the words "or lease" shall be inserted.


