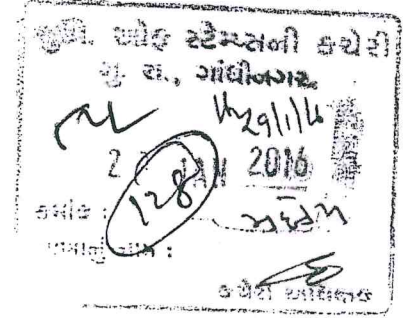

CONSTITUTION  
OF INDIA.

No. GHM-2016-51-M-STP-112014-3051-H1:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Additional Superintendent of Stamps, Class I in the Gujarat Stamp and Valuation Department under the Superintendent of Stamps, Gujarat State, namely:-

1. These rules may be called the Additional Superintendent of Stamps, Class I, Recruitment Rules, 2016.
2. Appointment to the post of Additional Superintendent of Stamps, Class I, in the Gujarat Stamp and Valuation Department, under the Superintendent of Stamps, Gujarat State, shall be made either :-
  - (A) by promotion of a person of proved merit and efficiency having "Very Good" benchmark for being considered fit for promotion as laid down in the Gujarat Civil Services

Classification and Recruitment (General) Rules, 1967  
from amongst the persons, who :-

- (i) have worked for not less than five years in the cadre of Deputy Superintendent of Stamps, Class 1 in the Stamp and Valuation Department, or Deputy Inspector General of Registration, in the Registration Department; and
- (ii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006:

Provided that where the appointing authority is satisfied that a person having the experience specified in Sub clause (i) above is not available for promotion and it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two - thirds of the period specified in Sub clause (i) above; or

(B) by temporary transfer on deputation basis from amongst the persons working on the cadre of the Gujarat Administrative Service in Senior scale or Selection scale.
