No: GHM/2018/43/STP/112018/612/H1:- In exercise of the powers conferred by sub-section (1) of section 3 of the Gujarat Prohibition of Transfer of Immovable Property and Provision for Protection of Tenants from Eviction from Premises in Disturbed Areas Act, 1991 (Guj. 12 of 1991), the Government of Gujarat hereby amends the Government Notification Revenue Department No: GHM/102013/15 /M/ STP/ 102000/MR/27/ H1. (Part-1), Dated the 5th April, 2013 (hereafter referred to as "the said notification") as follows, namely:-

In the said notification in Para 2 (b), the following shall be substituted, namely:-

"(b) specifies the period of five years and three months i.e. From the 1st April, 2013 to 30th June, 2018 as the substantial period, for the purpose of the said Act, ".


